**One paragraph about your organization’s history/work:**

Due to COVID-19 we had to cancel events like the annual Dory Days and Blessing of the Fleet but were able to continue fishing from Cape Kiwanda, advocating for traditional launching and fishing rights and contributing to our fellow community organizations. Thanks to our steady and increasing membership dues, the PCDA is able to provide nearly \$10,000 annually to other programs and projects in the community and fortunately this year was no different. Additionally, to address community needs around COVID-19, the PCDA was able to provide \$1,000 in funding to the Tillamook County Food Bank in the spring. In early fall the PCDA hosted a community cleanup day which included a beach cleanup of the traditional dory beach adopted through SOLVE, removing dozens of

wheelbarrow loads of sand from the curbs, sidewalks, and observation deck at the Cape Kiwanda parking lot, trimming back beach grass as well as weed removal from the area. The group of 20 PCDA supporters then moved to the Kiawanda Community Center to install the Chief Kiawanda sign that we rebuilt in the previous week after it had sustained wind damage and cleaned the gutters on the building.

The PUD purchases and receives power from the Bonneville Power Administration (BPA) and delivers it to customers through nine substations located throughout the County. We serve about 21,000 customers in an area of 1,125 square miles. Tillamook PUD is governed by a five-member Board of Directors, elected by the voters within its service area. The Board sets rates and policies, with the goal of providing the most benefit to our customers. Board meetings, which are open to the public, are held each month. PUDs tailor services to meet the needs of those they serve, and Tillamook PUD is no exception. We offer a wide array of programs for residential, commercial and industrial customers. Programs include weatherization, lighting efficiency, heat pump programs and much more. Employees participate in local civic and service organizations. The PUD offers educational opportunities to local schools and provides information, training and other services to communities, cities, police and fire departments. Tillamook PUD offers Community Support Grants to local non-profit organizations with projects that promote economic growth in Tillamook County. The Board will determine a budget each year for the program. Applications will be available early in each calendar year if funding for the program is approved.

Students complete the certificates and take them to TSG to redeem for their licenses. Certificates need to indicate the youth licenses desired. The WTB Foundation will pay for Youth Fishing Licenses which includes Angling, Shellfish, Columbia River Basin Endorsement, Youth Combined Angling Tag, as well as the Hatchery Salmon/Steelhead Harvest Card. The Foundation will also pay for the Youth Sports Pack: Angling, Shellfish and Hunting license; combined angling tag; spring turkey, cougar, general or controlled bear tag, elk and deer tags, upland bird and waterfowl validations and the Columbia River Basin Endorsement. We ask that only serious students request the Youth Sports Packet and have the skills, equipment, transportation, adult assistance, and permission of land owners necessary to utilize it as well as the intent to use it on multiple days of each season. To hunt before age 18 you must show proof of completion of a hunter education program.
